1. DRC Presidency congratulates EUA on its 20th Anniversary



The **DRC Presidency**, on behalf of the **Danube Rectors' Conference**, would like to express the most sincere congratulations to the European University Association (EUA) for the 20th Anniversary from the year when the two rectors' conferences of that time, the European Rectors' Conference and the European Union Rectors' Conference, merged to the present European University Association.

As an associated member, the Danube Rectors' Conference is especially interested to discuss co-relations between regional and European wide topics and to assure the holistic approach to our common challenges, as regional and local topics constantly become European wide issues sooner or later.

We see the most value of EUA to be a place for the exchange of views and discussion, a link of individual topics and common larger scaled issues, a union of higher education institutions and their national or regional representations for the realisation of the Magna Charta Universitatum.

In this connection, Danube Rectors' Conference shares EUA values regarding UN SDGs with emphasis on knowledge-based society, respect for regional diversity and inclusion.

We believe that EUA shall continue to defend and foster these values and be the voice of its members in front of not only EU policymakers, but also globally towards other higher education areas, where these values might be considered differently or might even not be in the foreground. 2. EUA General Assembly and board members election



23rd EUA GENERAL ASSEMBLY

Friday 30 April 2021 10:00-12:15 CEST

The 23rd Annual EUA General Assembly (GA) will take place online on Friday 30 April, 10:00-12:15 CEST.

During the meeting the anticipated election of the EUA board will be conducted. Among the candidates are the DRC Vice-President **Rector Ivanka Popović**, Rector of the University of Belgrade, nominated by the Slovenian national rectors' conference and Universities Austria (UNIKO) as well as **Rector Damir Boras**, Rector of the University of Zagreb, nominated by the Croatian national rectors' conference. Full list of the candidates is available on the <u>EUA official website</u>.

The election is aimed to fill the three vacant positions within the EUA board for the period 2021-2025 and running candidates will each briefly address the GA at the start of the meeting, before online voting is opened to eligible participants; election results will be announced before the meeting closes.

An updated meeting agenda will be circulated to members, together with access to related documents, on **Friday 16 April**, on the same day the registrations for EUA Members via the **Zoom meeting platform** close.

3. Danubius Young Scientist Award 2021 | Call for nominations



In 2021, for the eight time, the Austrian Federal Ministry for Education, Science and Research (BMBFW) and the Institute for the Danube Region and Central Europe (IDM) honour young researchers with extraordinary achievements in their scientific activity and output in relation to the Danube Region with the

Danubius Young Scientist Award 2021

This award will be granted to **14 young scientists** - one from each country (citizenship is crucial) that is part of the **EU Strategy for the Danube Region** (Austria, Bosnia and Herzegovina, Bulgaria, Croatia, Czechia, Germany, Hungary, Moldova, Montenegro, Serbia, Slovak Republic, Slovenia, Romania and Ukraine). The award will be **endowed with 1.350 EUR for each winner** of the Danubius Young Scientist Award.

It is expected that the award ceremony will take place in October/November 2021. The details will be announced in due time.

Moreover, thanks to the ongoing kind support by the JRC, the awardees will be

invited by the European Commission's Joint Research Centre to visit the **JRC in Ispra**, Italy in 2022.

The deadline for submitting nominations is **Friday**, **30th April 2021 at 23:59**.

EURASHE is organising the 30th Annual Conference held fully online about **"Professional Higher Education for Sustainable Development: Creating a Change that Endures"** on **20-21 May 2021** together with its members the Portuguese Polytechnics Coordinating Council (CCISP), the Polytechnic Institute of Porto and with the support of the Portuguese Presidency of the Council of the European Union.

All universities of applied sciences' leaders, the entire community of professional higher education, European businesses and public institutions and European students' representatives to attend the Annual Conference to share their experience and learn about trends, models and inspiring practices. The conference will be structured along the five pillars of Agenda 2030: People, Planet, Prosperity, Peace and Partnerships.

It is amply acknowledged that the achievement of the SDGs will not be possible without education, and not the latest Professional Higher education (hereafter – PHE), significant involvement in the cause. Thus, five years after the setting out of Agenda 2030, it is important to analyse the experience accumulated and to draw the way forward. For this reason, the purpose of the conference is to build up a set of Specific Recommendations and discuss a potential Action Plan for their implementation by professional higher education and its stakeholders over the next years.

8. European Countryside Journal: CALL FOR INTERESTS



The <u>European Countryside</u> is a reviewed International Scientific On-Line Journal in the field of rural research. The Executive Board has decided to prepare a special issue of the Journal on the topic "Rural development and state in the countries of former Austro-Hungarian monarchy after 1918".

The issue is intended as the 4th number of the 13th volume of the journal (December 2021).

The papers should be related e.g. with the following problems:

- Changes of agriculture, forestry and elaboration of local sources
- Development of rural settlements and their networks

- Changes in social system, education level, way of rural way, social capital
- · Central-European rural space as a tourist area
- Impact of the new integration within EU
- · and others

The deadline regarding the expression of interest (authors, the title of the paper and 2-3 sentences of the content) by April 30, 2021, while the deadline for the complete manuscript with all enclosures by August 31, 2021.

9. Putting Science into Standards (PSIS) initiative



Since 2013, the **Joint Research Centre of the European Commission (JRC)** and the **European Standardization Organizations CEN** and **CENELEC** have carried out an annual joint 'foresight on standardization' action under the **Putting Science**

into Standards (PSIS) initiative. The PSIS initiative aims to facilitate the identification of emerging science and technology areas that could benefit from standardization activities to enable innovation and promote industrial competitiveness.

The 2021 PSIS edition will be focusing on **Organ-on-Chip (OoC)** or Micro Physiological Systems (MPS), innovative devices that emulate human/animal biology and can reproduce one or more aspects of an organ's functionality. Among other benefits, they can lead to better testing of drugs and adapted treatments to genetic diversity, ethnicity, sex and age; reduce the cost of clinical trials and replace animal testing for cosmetic products, banned in Europe since 2013.

This event aims to facilitate the exchange of views on the future development of this technology, its application areas and stakeholder needs in order to identify **how European standardization can support its safe, widescale deployment.** Researchers, innovators, industries, standardizers and policy makers are welcome to join the discussion.

10. JRC Recruitment of 2-years post-doc position within the Exploratory Research programme



The JRC offers a vacancy for a Contract Agent within the Exploratory Research Project "Policy Mix and Behavioural Spillovers" (PoliSpill). The JRC Exploratory Research Programme (ER) is a strategic initiative characterised by ideas that might lead to novel results and qualitatively enrich current JRC scientific work. The vacancy is within the Directorate for Energy, Transport and Climate. The directorate supports the relevant policy DGs with independent, technical and scientific evidence in the areas of Energy, Transport and Climate.

The 2 years post-doc position regards the Exploratory Research programme REUSE (Novel Modular and Reusable Panels for Safe & Carbon-Free Buildings) and the operational scientific research will take place in the Energy Efficiency and Renewables unit.

11. PASIFIC Fellowship Programme



The **PASIFIC Fellowship Programme** is a unique opportunity for researchers who want to pursue a research programme in a dynamic environment. It will enable scholars of all nationalities and across all scientific disciplines to establish their **scientific independence** and conduct **ground-breaking research**.

The 2-years-long fellowship will take place at the **Polish Academy of Sciences** (**PAS**), which is one of the most prestigious research institutions in Poland. The selected participants will have the **freedom to choose their research area**, research supervisor, host institute as well as secondment organisations best suited for their research and career development.

The programme consist of a monthly allowance of approx. €2,500 net. Those, who decide to come to Poland together with their families, may be entitled to an additional family allowance. In addition, they will be granted a research budget of up to €93,000 per project.

Only 50 outstanding candidates will be selected for this years' edition. The **first call,** in which 35 PASIFIC fellows will be recruited, will be open from the 15th of March 2021 to the 30th of June 30th 2021. Selected researchers will be informed about evaluation results after approx. six months. They will be expected to come to Poland between January 2022 and March 2022.
